The State Level Advisory Body shall meet at least one in every six months to review the matters related to implementation of these rules, state policy and strategy on solid waste management and give advice to State Government for taking measures that are necessary for expeditious and appropriate implementation of these rules.

3. The copies of the review report shall be forwarded to the Tripura State Pollution Control Board for necessary action.

4. This will come into force with immediate effect.
